

ceo report

In preparing the Centacare CEO report for the 2019-20 year, the shadow of COVID-19 pandemic hangs large over any commentary I may wish to make. It has impacted the majority of 2020 and it has dominated our every thought and action way beyond any other issue that may have arisen throughout this extraordinary year.

Firstly, I would like to say on behalf of the Board and Executive team, how very proud we are of the Centacare team and how magnificently staff responded to the many challenges that were placed before them because of COVID-19. It was almost on a moment's notice that staff were relocated from our many offices and asked to work remotely from home. It was an astonishing sight to see our staff packing their cars with their office setup comprising of chairs, computers etc. and heading off to set up their home office. The pandemic resulted in more than 90% of our team working from home and in many cases with the addition of home schooling duties, however, staff continued to provide excellent services for our clients in their usual caring way.

It is important to also acknowledge all of the members of our team, who despite the risks associated with face to face delivery, continued to provide services to our clients in our residential care and accommodation facilities and the staff who continued to visit clients and their families at their homes to confirm their physical and mental wellbeing.

Throughout the pandemic, we have seen an increase in the demand for our Emergency Relief services with many individuals, couples and families experiencing financial hardship. At least 40% of people approaching us for

Emergency Relief assistance have never utilized the service previously, demonstrating the deep impact the pandemic has had on our community.

This year saw us expand into the provision of residential care facilities for young adolescents via our resi-care program. With the assistance of the Diocese, for which we are very grateful, we were able to procure a very functional house and with the deft touch of our resi-care team, they have turned a house into a home. The heartfelt response from the kids in our care reflects the dedication of the team as they have provided an environment for the kids to grow and flourish.

We have also acquired additional office space in Ballarat with the opening of our Bridge Mall premises. The requirement for more space is a sign of the ongoing disciplined growth strategy that the Board has encouraged Centacare to pursue. Bishop Paul formally opened the Bridge Mall office late last year and it has provided us with the necessary office capacity to accommodate our growing workforce.

At Centacare, one of our underlying mantras is the "no wrong door" policy and despite the difficulties posed by COVID-19, our staff have remained true to that principle and continued to care and provide the dedicated service that we are so well known for throughout the Diocese. It still holds true that the only qualification you need to be a client of Centacare, is to be vulnerable or disadvantaged.

It has been recently announced that Centacare will be merging with the other Diocesan Social Service agencies in Victoria, CatholicCare Melbourne-Gippsland and CatholicCare Sandhurst to create CatholicCare Victoria. CatholicCare Victoria will come into being on 1st of January. It is an exciting time for Centacare, as it will allow us to increase the services to our clients, present greater opportunities for our staff and grow our services in other parts in Victoria.

I sincerely thank Bishop Paul for his ongoing support of Centacare and Centacare Housing and the members of both the Centacare Board and the Centacare Housing Services Board for carrying out their duties with outstanding dedication and diligence. I also wish to thank the Executive team and the Centacare staff for their excellent ongoing commitment to the organisation and its clients, in what has been an extremely challenging year

general manager review family + community services

While the last months of 2019-20 presented an unprecedented environment both within the workplace, in our personal lives with family and friends and globally, we can still acknowledge so much that was achieved by staff in collaboration with clients, our sector and network partners throughout the year.


There were community presentations by both the Ballarat and Mildura Family Mental Health Services staff and participation at the Bacchus Marsh Seniors Expo by Advocacy Services staff. The Northern Kinship Care team, led by Jan Cook, Senior Case Manager, facilitated Kinship Care Week activities for carers, receiving extremely positive feedback from those who participated. Family and Relationship Services staff co-facilitated with Ballarat Community Health to deliver Happy Parents Healthy Kids and also participated in Ballarat's Biggest Playgroup. Helen Diamond, Family and Relationship Services Practitioner, was invited to join Women's Health Grampians to host webinars in response to COVID-19 restrictions, as well as being invited to contribute to the City of Ballarat Parent Self-Care website. Marea Sholly, Practitioner, Family and Relationship Services, South

West, contributed to a two day forum in Cobden to support assimilation of African families into their local community.

Paul Hartwood, Support Worker, Mental Health Planned Respite, was active in organising and chairing the Grampians Mental Health Week Committee, which launched 'The Art of Mental Well-Being' during Mental Health Week 2019. Sue Grant, Coordinator, Mental Health Services, together with team members, supported the successful application by a carer group for funding to enable ongoing peer support via social activities and strategies for self-care and education sessions on mental health specific topics. Advocacy Services staff worked closely with the Office of Housing (OoH) providing monthly community outreach support to residents of public housing estates. The Advocacy Services staff also developed an initiative whereby tubs full of gloves, beanies, blankets and socks were provided to a range of local agencies for community members who need additional support during the colder months. The initiative was expanded to include hygiene packs. The response to the initiative has been very positive and assists in strengthening a more collaborative model of service delivery between organisations. Supporting Connections program staff supported approximately 80 residents in moving to new homes when Kallara Care Supported Residential Service (SRS) relocated to Bendigo, and Landora SRS closed. The Advocacy Services team again hosted the annual SRS Christmas party at Bray Raceway in early December. This event is always highly anticipated by residents and staff of the SRS's, providing an opportunity for them to catch up with friends.

Rebecca Real, Family Mental Health Support Service Mildura, took the lead in facilitating the display of artwork in the Mildura office Reception area as part of the new Art for Hire scheme with Christie Centre, a local provider of disability services. Rebecca also organised Aboriginal artwork in the Mildura office training room and at the entry to the office, as well as words of welcome in a number of different languages on the Centacare sign. The Mildura office now offers a culturally appropriate welcome to all members of the community.

Through the Centacare No Interest Loan Scheme (NILS) program, we supported Good Shepherd Microfinance in the facilitation of a financial management workshop at the Ballarat Regional Multicultural Council (BRMC). Centacare was invited to Chair the Catholic Social Services Australia (CSSA) / Catholic Social Services Victoria (CSSV) 2020 Annual Conference Restorative Justice Workshop. Our Mental Health programs also successfully completed the mid-cycle assessment against the National Standards for Mental Health Services.

Centacare was well represented at the 2019 National Family and Relationship Services Australia (FRSA) Conference held in the Hunter Valley, with four staff presenting papers: Jessy Edmonston (Family Relationship Centre) Adults on the Autism Spectrum - considerations for postseparation support services; Tanya Burrows (Family Mental Health Support Service) Children and young people, education and service providers: A collaborative effort to achieve positive outcomes; Kim O'Neill (Family and Relationship Services) 25 Years of Preparing for Marriage Program: From then to now, and to the future; Graeme Davy-Watts (Family, Community and Mental Health Services) Scaling Up Family Violence Interventions in Rural Populations.

We were invited to join the inaugural Western Victoria Primary Health Network Psychosocial Support Stakeholder Group and to also partner with the Ballarat Veterans Centre. Jacinta Cook, Manager, Family Relationship Services, was invited to join Catholic Education Office 'Safeguarding Children Working Group' and Graeme Davy-Watts, Manager, Family, Community and Mental Health Services, was invited to Chair the Murray PHN Suicide Prevention Trial and to also participate on the Mallee Area Men's Family Violence Intervention Steering Group. There was an invitation to participate in the development of the DHHS North Division Care Services Strategy to address challenges and implement actions that will improve the experiences and outcomes for children and young people in care.

There was continued participation on the Council to Homeless Persons (CHP) Executive Advisory Group for the development and implementation of the Victorian Specialist Homelessness and Transition Plan, which included input into the development of a state-wide Workforce Strategy for homelessness service providers. We were also invited to participate on the Central Highlands Homelessness Emergency Accommodation Response Team (HEART), to further support responses to people experiencing homelessness as a result of the COVID-19 pandemic.

Portfolio staff continued representation of Centacare across many other networks

and alliances, including the CSSV Domestic and Family Violence Working Group, the Partnership of Victorian Family Relationship Centres, FRSA, Family Law Pathways in the Grampians (lead) and Barwon South West, Central Highlands Primary Care Partnership, Central Highlands Homelessness Alliance, headspace Consortia, Golden Palins Shire Emergency Management Committee, as lead personal support provider, Mallee Child and Family Services Alliance, Mallee Best Start Partnership, Mallee High Risk Infant and High Risk Youth Panels, Northern Mallee Mental Health Alliance, Northern Mallee Family Violence Network, North Division Kinship Care Advisory Group and the Horsham Seasonal Conditions Committee.

With the end of the Partners in Recovery program, the federal Department of Health provided limited-term funding for the Psychosocial Transition Support Program, to enable continued support for people with a diagnosed mental illness to transition to either an NDIS Plan, or to other support services. The Department of Social Services (DSS) extended the Mental Health Respite: Carer Support program until 31 May 2020. This was very welcome news for the many carers who were supported by the program and allowed a transition period to the new Integrated Carer Support Service: Carer Gateway Regional Delivery Partners model of support.

There was an increase in our Emergency Relief program funding, which enabled increased support to individuals and families impacted financially by the pandemic. Staff were able to assist with food and fuel vouchers and payment of utility and other accounts to support individuals and families in meeting the necessities of daily life during these challenging times.

Virginia Louey, Manager, Homelessness
Support and Advocacy Services, was
successful in an application for project funds
under the HACC Program for Young People.
The funds will support training for individuals
who are socially isolated, and which has been
exacerbated by the pandemic, in the use of
technology to assist in maintaining health
and social connectedness.

Jacinta Cook and Jenni Ryan, Coordinator, Pastoral Care Services, successfully negotiated a new Pastoral Care services contract with the Hamilton Specialist School. Centacare now provides pastoral care services across twenty schools throughout the Diocese. The Catholic Diocese of Ballarat Foundation is providing three-year funding to support increased reach of Centacare's counselling and relationship services to the Ouyen community.

The Department of Health extended the Centacare Commonwealth Home Support Program (CHSP) funding through until 30 June 2022, while the Attorney-General's Department extended the Family Law Pathways program for a further twelve months until the end of June 2021.

We were very appreciative of funds donated by Ballarat Rotary to support much needed furniture upgrades at our crisis accommodation units in Ballarat.

The development and implementation of program COVID-19 pandemic response plans enabled rapid adjustment to the way we continued support to our clients. Telephone and video conferencing capabilities were strengthened in all programs to ensure continuity of service delivery, with in-person support maintained in accordance with

government direction and guidelines to ensure the safety of everyone. Staff were also able to adapt many group-based programs to provide on-line sessions. Feedback has been very positive from clients, with the option for contact via technology providing greater flexibility for many people, including less requirement to source child-minding options and employment leave, as well as reduction in travel for those who live outside regional centres.

I acknowledge all our staff for their commitment and diligence in working together within our community to provide such a high level of service to those people who seek out our assistance.

Finding Balance

Facing the risk of eviction and the recent loss of support services, Bob found himself in an isolating and frightening situation.

Bob was living in a community housing property, which he was finding difficult to maintain, and he was often encountering conflict with his neighbours, placing his tenancy at risk.

Having a significant history of trauma, an intellectual disability and complex mental health issues, Bob often becomes aggressive when stressed.

Bob's aggression had led to the loss of NDIS support, as staff were unable to work with him due to his behaviours and his funding and other in-home supports eventually dwindled.

In need of assistance and at risk of

homelessness, Bob was referred to Centacare's Community Connections program. Community Connections provides a range of supports for clients who are at risk of homelessness, or are homeless and together identify the client's challenges, and what needs to be done to resolve them.

Bob was connected with a case manager and they promptly developed a trusting relationship.

Working in collaboration, the case manager and Bob were able to secure his tenancy through advocating to the community housing provider to resolve issues with the neighbours and arranged for the garden and home to be cleaned to a reasonable standard. Bob was connected with a psychiatrist for a mental health assessment leading to regular

appointments and medication compliance. A new NDIS support coordinator with extensive experience working with complex clients was arranged and Bob was also supported when attending a range of allied health assessments and meetings to ensure he felt safe and was able to engage appropriately.

With the appropriate supports in place, Bob is now rarely aggressive, feels less anxious and is able to self-regulate more effectively, his tenancy is secure and he has confidence in himself to complete things on his own, thus gaining back his independence.

general manager review family, community and employment services

The second half of 2019-2020 has certainly been a period that has presented many challenges for all within the workplace, in our communities and personal lives. During this time, our staff and programs have continued to support our clients in collaboration with our sector partners; albeit in some instances in a very different way. Our staff are to be commended for their continued commitment to Centacare clients and their support of each other within our Centacare community. The leadership group would particularly like to recognise those staff that have continued to provide frontline, face to face services to our clients under challenging circumstances during the pandemic.

The Victims Assistance Program (VAP) continued community education initiatives across the locations in the first half of the year and stakeholder engagement remained a key feature during the pandemic, reminding stakeholders that services were continuing via a range of platforms. The dedicated team have continued to provide services to victims of crime throughout the year.

Centacare has continued to be the VAP sector representative on the statewide Victims of Crime Consultative Committee. The Committee provides a forum for victims of crime and relevant justice and victim service agencies to discuss victims' policies, practices and service delivery; advise the Attorney-General and Minister for Victim Support on policies, practices and reforms relating to victim issues and support services, promote the principles of the Victims' Charter Act 2006, and report on any matters referred to it by the Attorney-General or the Minister for Victim Support.

Minister Hon Natalie Hutchins delivered a statement of recognition to Victim Services across the state, gratefully acknowledging the impact of uninterrupted services during COVID-19. This is a well-deserved acknowledgment from the Minister of the hard work of the team to support victims of crime in challenging circumstances.

Centacare look forward to the release of the Victims Assistance Program Statewide Review. It is anticipated there will be adjustment to the current statewide model which carries a very high case load for program staff. The Department of Justice and Community Safety informed Centacare that our VAP contracts are extended until the end of June 2022. This is in relation to awaiting the outcome of the Victims Services Review.

The committed and skilled team across Family Services have continued to provide quality services to the community, working with increasingly complex family situations, and as an essential service continuing to provide outreach to clients where required during the pandemic.

Centacare was nominated and has accepted to participate on the Ballarat Early Parenting Centre, a Community Advisory Group (CAG). The CAG will support planning for the new Ballarat Early Parenting Centre and is cochaired by Juliana Addison MP and Michaela Settle MP. This provides a forum for members of the local community and key local organisations to participate in the project's development to ensure that the views and aspirations of the community are captured.

Our Department of Health and Human Services (DHHS) funded programs have continued to respond to the Child and Family Services reforms. DHHS identified four key areas of focus in the Early Help phase of the reforms: Expectant Parents, Children in Residential Care, Children Entering Care, Cumulative Harm.

Centacare has continued active participation in the various Child and Family Service
Alliances across Central Highlands and the Wimmera South West. In Central Highlands,
Centacare has been significantly involved in the development of the Collaborative
Network; which will bring together senior representation from the Family Services, Care Services, Family Violence and Homelessness sectors, into a strategic collaborative forum.

There has been ongoing representation on the Central Highlands Integrated Family Violence Committee (CHIFVC) and Co-Chairing of one of the CHIFVC's strategic priorities; the Data, Outcomes and Evidence Working Group.

Centacare is participating in the newly formed Ballarat 4 Kids (B4K) Coalition, funded by DHHS and auspiced by Ballarat Health Service. The group is looking to design a Kid Friendly City in Ballarat. The Coalition will undertake: community, consumer and other stakeholder engagement and communication so the voices of children and their parents and carers are heard.

The Family Services program celebrated Children's Week in 2019 with an art competition for children and their families engaged with the program with prizes awarded. Art and craft packs for each child who participated.

Centacare's experienced Employment
Services team have continued to provide
services and engage participants
throughout the year. Despite the program
being impacted on by both the bushfires
and pandemic, where mutual obligations
compliance from job seekers has not been
required, the majority maintained their
engagement with the program. Service
delivery throughout much of the year has
been via tele or video conferencing and has
been quite successful.

Centacare leadership participated in a meeting with Nathan Smyth (Deputy Secretary Department of Education, Skills and Employment). The Deputy Secretary was impressed with much of what Centacare Employment Services are achieving and was particularly impressed with the continued remote service provision strategies through the pandemic.

Employment Services management attended the jobactive CEO Forum in Brisbane November 2019. The New Employment Services Trial (NEST) taking place in South Australia and Northern Sydney was presented in detail. This trial will inform the new Employment Services contracts from June 2022. Management also attended the

Disability Employment Services conference in August 2019, which provided many ideas for the ongoing development of the program.

Centacare Employment Services Consultant Robyn Reeves won a scholarship to attend the National Employment Services Association conference in August 2019.

The innovative Youth Justice and Empower Youth teams have continued to provide services to young people in our communities, with a good uptake of the use of on-line platforms to stay connected with young people, as well as outreach where this has been required.

During 2019, the Youth Justice Group Conferencing program (YJGC) participated in the Restorative Family Meeting Pilot in partnership with the CAFS Adolescent Family Violence program. This pilot took place in three locations across the state where an Adolescent Family Violence program exists.

The Youth Justice Community Support Service (YJCSS) contract has been extended until the end of June 2023 and the YJGC contract has been extended until the end of June 2021

New Programs/Funding

Residential Care

Centacare commenced the new Residential Care program, based on a therapeutic model, in 2019. Due to unforeseen property delays the program operated in a contingency phase for some months. The team excitedly moved into our new property on the 6 July 2020! Being in our own care home, with the stability to provide quality care in a quality environment, has made a significant difference to the effectiveness of our program. Centacare has put together a home that both the young people and carers are proud of; an essential element of a quality therapeutic care program.

Message from a carer to the leadership group about the response of the first two young people to move into our care home on their first day:

'Thank you all for your amazing work in setting up a beautiful home for our young people. They were both super excited to move in and couldn't wait to let everyone know what a beautiful home they have. One of the young people stated if we make this place work maybe all resi houses can be like this. Staff agree and informed her that all young people deserve an environment like this one'.

Intensive Case Management and Adolescent Support (Wimmera)

Centacare was invited by the DHHS Wimmera South West region, to deliver the following services. This presented an opportunity to increase our services to vulnerable young people and to expand Centacare's Youth Services program in the Wimmera.

Client Placement Support Services - Intensive case management services targeted at young people aged 12 to 18 years in out of home care, who are subject to child protection involvement and who demonstrate a high level of risk behaviours. The program funds a range of services to meet the needs of individual young people.

Adolescent Support - Young people aged 12 to 17 years who are current or past clients of the statutory child protection system. The program supports young people who are in crisis and may be displaying challenging behaviours. The program can assist them to live safely with their family or independently and provides a continuum of services depending on the needs of the young person.

Targeted Care Packages - intensive case management support for a young person in out of home care.

Once again this has been a productive year, with program development of existing and new programs. The coming year will focus on a continued commitment to client outcomes, program review, evaluation and development across the portfolio. Professional development and support of staff has had a strong focus throughout the year.

I would like to acknowledge the wonderful commitment, skill and dedication of the leadership group and staff across Employment Services, Youth Services, the Victims Assistance Program and Family Services; who have continued to deliver effective, high quality services to the community throughout an unprecedented era. Thank you once again for your professionalism and another fantastic year's work.

A Sense of Relief

Casey was referred to Centacare's Family Services program when she was looking for a safe way for her and her children to leave an unsafe home situation.

Centacare's Family Services program provides in-home support to families who may be experiencing difficulties or are at risk. Casey's case manager heard what Casey was saying and worked out a plan with Casey to do something. In turn, Casey developed trust in her Family Services worker. As Casey put it:

"It look me four tries before I was able to leave. All the money I was trying to save, I had to spend on hotel rooms so I could have a break. I couldn't see a way out and because there was no physical violence it was harder to prove the emotional side of the violence".

With support from the Family Services program, Casey was able to leave and provide a stable and safe environment for herself and her children.

"The Case Manager has been with me since the day before I left, if I didn't have their support I'd be living an unhappy life. I am glad I had them to talk to, otherwise I'd be still trying to save up the money to leave and I think my sanity would be gone. They believed in me" said Casey.

Casey is now able to enjoy her newfound life with her children.

With the departure of two very experienced and great contributors namely Dan McGlade and Tony Godfrey, the Board were fortunately able to recruit two wonderful members in Kevin Murnane and Stephen McArdle. Dan McGlade has made an extraordinary contribution to the organisation as Chair of CHS through significant change. Most importantly leading the organisation to achieving the seven performance standards required by the Housing Registrar, which has again been maintained this year. He is therefore leaving the organisation with a very strong legacy and one that enables us now to focus on creating growth in housing numbers and therefore increased availability in the social housing area, a need becoming more apparent in these times. Tony Godfrey also has been an integral part of this success and his work in the daunting area of compliance has helped achieve our success and laid an extraordinary foundation for the future. It was with trepidation the Board accepted these resignations, however we have been blessed with the addition of great wisdom and experience with Kevin Murnane and Stephen McArdle accepting our invitation to join CHS.

Whilst continuing to manage 69 properties CHS have undertaken significant refurbishment of around 30% of these. The excellent management of properties and tenants is a testament to the work being done by the team and our regular monthly reports and monitoring indicates the success of this work.

These have been difficult times and there is more to come. There remains a massive lack of social housing in Ballarat and our region and we are now concentrating on the opportunities ahead, working closely with the State Government to increase available

housing to those in need. To this end we are commencing construction of nine units at Mitchell Park and work is well under way for two houses for women and children escaping family violence thanks to the assistance of the Catholic Diocese and Federal Government. We have a number of other opportunities and we are hopeful of successful outcomes again to provide social housing in the region. We are proud that Matt Cosgrove has joined our team and is extremely active in sourcing opportunities and funding, with a number of applications and opportunities in the pipeline. Matt has wonderful experience in the property area and is an important cog in the future plans of the organisation.

We are delighted with our current Board and their enthusiasm and commitment for our goals. Hal Bisset for his knowledge of the entire social housing spectrum and Kathleen Neale whose commitment to the organisation is greatly appreciated. Our thanks to all our dedicated and committed team, Jackie Moriarty, Kathy Samuels, Carl Eddy, Matt Cosgrove, Jane De Valle, Nick Kierce and what would we do without the organisational abilities and understanding of the industry of Debbie Mannix? Our thanks also to Ross Wheatland for his invaluable work and guidance. We thank Bishop Paul Bird, Maureen Waddington and the Centacare Board of Directors for their confidence, and support in what we are doing.

Next year will be an extremely important one for us all, however with the foundation established and the team we have, I look forward to it with excitement and enthusiasm. The outcomes we can achieve in the social housing area in the future can make a significant difference.
